Instructions for candidates

- 1. At the time of counseling / admission candidates must use face covers/masks within and outside University premises.
- 2. Formats of selected documents required are specified in the e-Prospectus for Academic Session 2020-21 which is available at http://mgcub.ac.in/pdf/ MGCUB-Prospectus-20-21.pdf
- 3. Admission shall be strictly based on **merit list** derived from the **composite score** taken together on the basis of giving 70% weightage to the Entrance Test and 30% weightage to the Interview / viva-voce.
- 4. **Admission fee** for the MPhil programme is **Rs. 19,718/- .** Admission fee would be deposited on the day of admission after document verification through challan. Fee structure and other details are provided in the e-Prospectus for Academic Session 2020-21.
- 5. If at any stage it is found that the applicant has furnished wrong information in the online application form then the admission would be cancelled.
- 6. **Admission** into MPhil programme **would be confirmed only after** document verification and submission of proof of fee deposit through challan.
