Notice for Open Counseling for the Admission in M.A (Political Science) against Vacant Seats Session 2024-25

The **Spot Counselling** for admission against vacant seats in M.A. (Political Science) programme is scheduled on **5th August, 2024** at **Department of Political Science, MGCU, Motihari Bihar**. The candidates may appear in the spot counselling, and the criteria for admission would be based on a composite score, which will be determined as under:

S. No.	Components	Weightage of different components of the composite score (out of 100)
1.	Percentage of Marks in 10 th	20%
2.	Percentage of Marks in 10 + 2/ Intermediate	35%
3.	Percentage of Marks Graduation	45%

All the candidates who have met the eligibility criteria for the admission in M.A. (Political Science) at Mahatma Gandhi Central University, Motihari may appear for open counseling for filling up the vacant seats left.

Eligibility Criteria: B.A degree in Political Science or any other Bachelor degree with a minimum 50% marks or equivalent grade for unreserved category and 45% marks or equivalent grade for SC/ST/OBC (Non-creamy layer)/PWD candidates

1. Admission shall be based on the composite score as mentioned above.

4. Candidates who fail to report for admission along with all the original documents on the scheduled date and time shall forfeit their claim to be considered for admission.
5. In case of tie, senior candidate on the basis of Date of Birth shall be given preference. In case of any dispute, the decision of the University administration shall be final.
6. The admission of candidate who has passed his/her qualifying examination from a Foreign University will be subject to his/her qualification being found equivalent to the qualifications prescribed by the University.
7. The candidates shall be required to pay the fees in the form of **Challan** at the time of admission.
8. Admission shall be granted only on the payment of fees on the specified date.
9. Candidates who fail to make payment on the date of admission shall not be considered for admission and the seat will be given to the next candidate in the merit list.
