

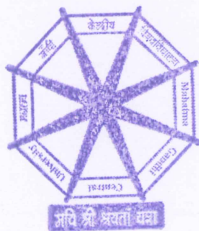
## OFFICE ORDER





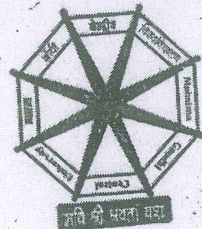
## OFFICE ORDER


