- 1. This is with reference to Advertisement No. MGCU/2023/R/NT/01 dated 1st December 2023 issued by the university vide which 1 (One) Unreserved post of Deputy Registrar was advertised to be filled up on permanent basis.
- 2. In response to aforesaid Advertisement dated 1st December 2023, total 20 (twenty) applications were received for the post of Deputy Registrar through Online Mode (SAMARTH Portal) on or before the last date prescribed for submission of online application i.e., 21st December 2023 (Thursday).
- 3. A Committee constituted for the purpose, checked and verified the records of each applicant and their eligibility strictly in accordance with the minimum eligibility criteria prescribed by the university and prescribed in the aforesaid Advertisement dated 1st December 2023.
- 4. The Committee has screened all the applications with due care however in case of misrepresentation of facts by the candidate found at any stage the candidate will be disqualified.
- 5. Call Letters to the provisionally eligible candidates to appear before the Selection Committee for Interview is being sent through **email only**. Therefore, the candidates are advised to check the University Website and their Email ID regularly.

IMPORTANT NOTE: Provisionally Eligible candidates are being allowed to appear before the Selection Committee subject to production/submission of requisite document as mentioned against their name on the date of Selection Committee Meeting failing which they shall not be allowed to appear before the Selection Committee.

- 6. Although all efforts have been made to ensure accuracy in preparing the list, the possibility of inadvertent error or typographical mistake/omission cannot be ruled out. The University will incorporate the genuine and justified requests, if any, on receipt from applicants. Therefore, the applicants are advised to go through their details carefully and in case of any discrepancy, the applicants are advised to bring the same to the notice of the University for necessary correction(s) clearly mentioning the Name of Post; Sl. No.; and Page No. at which their names figure in the list by writing an Email to osdadmin@mgcub.ac.in latest by 24th September 2024 (Tuesday).
- 7. No request for corrections shall be entertained after 24th September 2024 (Tuesday).

9. **It may be noted that:**

- a. The recommendation with regard to short-listing of applicants to be called to appear before the Selection Committee for Interview has been made on the basis of their claim/information/certificates furnished along with their application forms.
- b. The applicant will be solely responsible for the authenticity of the submitted information through online mode on 'SAMARTH Portal'.
- c. Applicants shall have to substantiate their claim through submission of original documentary proof, prior to their Interview with the Selection Committee.
- d. Applicants must ensure that the documents/enclosures submitted are correct and that they meet the minimum eligibility requirements, failing which they may not be allowed to appear for Interview with the Selection Committee.
- e. The eligibility of the applicants has been determined as on the last date for the receipt of online applications, i.e., **21**st **December 2023 (Thursday)**.
- f. The Selection Committee may decide its own method for evaluating the performance of the candidates in Interview.

- g. Those in-service provisionally eligible candidates who have not submitted their applications through proper channel are advised to submit NOC at the time of Interview.
- 10. Applicants are advised to visit the University Website at regular intervals for the regular and updated information in the matter.
- 11. No TA/DA shall be paid for attending interview.
