**Note:**

1. Provisional admission shall be strictly based on merit list derived from the composite score of marks of relevant examination and marks of interview in accordance with the provisions of the University Ordinance.

2. Candidates are required to report personally on the scheduled date and time to the venue along with required documents.

**3. Candidates are required to come with a Research Proposal to be presented before the Department Research Committee (DRC) during the interview.**

4. All candidates are advised to check their eligibility for respective programmes as notified by MCGU admission prospectus 2024-25 (<https://mgcub.ac.in/pdf/202411031241151e452aad30.pdf>) before appearing for Interview-cum-Admission.

**5. Merely obtaining the cut-off percentile does not guarantee admission.**

6. Candidates who fail to report personally for provisional admission along with all the original documents on the scheduled date and time shall forfeit their claim to be considered for provisional admission.

**7. The candidates shall be required to pay the fees through Samarth portal after final provisional result declaration.**

8. Provisional admission shall be granted only on the payment of fees by due date.

9. Candidates who fail to make the payment by due date shall not be considered for provisional admission and the seat will be given to the next candidate in the merit list/waiting list (if any).

10. In case of any dispute related to the provisional admission, the High Court of Patna shall have the jurisdiction.

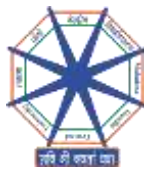
