#### **Instructions:**

Candidates are invited for screening and interview for the PhD program in Sociology. Please note the following important instructions:

- Provisional admission shall be strictly based on a merit list derived from the composite score of Marks from the NET Exam and Marks of Interview/Viva-voce/Presentation, in accordance with university rules.
- Candidates must report personally on the scheduled date and time at the venue with all required
  original documents. Please also bring three copies of each document for official purposes along with
  valid identity proof and five passport size photographs.
- 3. The **screening process** may lead to **rejection** and **non-shortlisting** of candidates if the requisite original documents and eligibility criteria for PhD admission are not fulfilled as per UGC regulations and University guidelines. Candidates are advised to ensure that they meet all requirements and bring the necessary documents to avoid disqualification.
- 4. Candidates must bring a **Research Proposal** (5-10 pages) and present before the Department Research Committee on their area of research interest at the time of the interview. Additionally, send a copy of the research proposal to the following email ID: **headsociology@mgcub.ac.in** on or before **18th January 2025 by 05:00 PM**.
- 5. Each candidate must prepare a **7-minute presentation** based on their research proposal.
- 6. Ensure that you **check your eligibility** for the respective programs as notified in the MGCU admission prospectus 2024-25 (http://mgcub.ac.in) before appearing for the interview.
- 7. Merely obtaining the **cut-off percentile** does not guarantee admission.
- 8. Candidates who **fail to report** personally with all original documents at the scheduled time will forfeit their claim to admission.
- 9. The screening process shall be strictly conducted, and all certificates as per University and UGC guidelines must be carried in original. Failure to present the required documents will result in rejection and non-shortlisting of candidates.
- 10. The **final list** of selected candidates will be displayed on the University website. The candidates are advised to keep visiting regularly to the website.
- 11. Candidates are advised not to resort to **illegal means** to secure a PhD seat, as this will lead to **cancellation of their candidature**. The Department of Sociology upholds strong ethics and high academic standards.

- 12. Candidates shall pay the fees through the **Samarth portal** after the final provisional result is declared.
- 13. **Provisional admission** will only be granted after the payment of fees by the specified due date.
- 14. Candidates who **fail to pay the fees** by the due date will lose their provisional admission, and the seat will be offered to the next candidate on the merit/waiting list (if applicable).
- 15. Any **addendum/corrigendum** to this notification will be published on the University website (www.mgcub.ac.in). Candidates should check the website regularly for updates.
- 16. No **TA/DA** will be paid to candidates for appearing in the interview.
- 17. The scheduled interview may **continue till late evening** depending on circumstances. Candidates should make arrangements for stay accordingly.
- 18. In case of any dispute, the **High Court of Patna** shall have jurisdiction.

- 4. Applicants must ensure the **validity** of their **UGC-NET-JRF/NET 2024/SET/GATE** or any other valid certificate. These certificates will be verified during the screening process, and failure to present valid, up-to-date documents will result in disqualification.
- 5. Five copies of recent passport-size photographs.
- 6. Self-attested copy of AADHAR card.
- 7. Original research articles/certificates of research presentation and academic work published, if any.
- 8. Bank Account details of the student, i.e. Account No., IFSC-Code, and Name of account holder & address of Bank.
- 9. A Character Certificate from the Head of the Institution last attended.
- 10. Affidavit for intervening period/gap of over three years on 100/- stamp paper, if applicable.
- 11. SC/ST/OBC/PwD/EWS Certificate as per GOI rules, wherever applicable.
- 12. No Objection Certificate (NOC) from Employers, wherever applicable.
