Instructions for candidates

1. **Admission fee** for the PhD programme is Rs. 24,750/-. Admission fee would be deposited on the day of admission after document verification.
2. If at any stage it is found that the applicant has furnished wrong information in the online application form then the admission would be cancelled.
3. **Admission** into PhD programme **would be confirmed only after** document verification and submission of proof of fee deposit.

Admission of candidates seeking admission after a gap of three or more academic years of their taking certificate/ diploma/degree/postgraduate degree from this University or any other University/educational institution/Board, shall be subject to the clearance by the **Admission Review Committee** consisting of the Dean, Students' Welfare (DSW), the Dean of the School concerned, the Head of the Department concerned and the Proctor.

The candidates are required to be present in person and bring the following documents in **original** as well as a set of **attested photocopies** at the time of reporting for admission:

1. Copy of submitted online application form.
2. Mark sheets and certificates of 10th and 12th.
3. Marks sheet and Certificate of Graduation and Post- Graduation, etc.
4. Certificate of UGC-NET-JRF/ NET/ SLET/GATE/ Teacher Fellowship, etc.
5. Five copies of recent passport size photographs.
6. Self-attested copy of AADHAR card.
7. Original Extra Co-Curricular Activities Certificates, if any.

11. Affidavit for intervening period/gap of over three years, if applicable on 100/- stamp paper.
12. SC/ST/OBC/PwD/EWS Certificate as per GOI rules, wherever applicable.
13. No Objection Certificate (NOC) from Employers, wherever applicable.
