In this connection, the following is submitted for information of the Hon'ble Members of Executive Council:

- i. For the post of Section Officer, all the top three candidates (on the basis of composite score) were issued Offer of Appointment Letters after verification of their documents/eligibility. Out of total three Section Officers, two have already joined the University.
- ii. For the post of Assistant, Mr Amit Kumar Singh (Roll No. 20442) who qualified the Written Examination and was in order of merit for final selection, was found ineligible for the post of Assistant by the Committee constituted for verification of documents/eligibility based on Experience and Incomplete Application Form. The Offer of Appointment Letter to rest of the selected candidates on the basis of merit in Written Examination have been issued and they are likely to join shortly.
- iii. As per rules, on the expiry of the period of probation, the following steps should be taken to obtain the assessment reports on the probation and to:

- a. Confirm the probationer / issue orders regarding satisfactory completion of probation period, if the probation has been completed to the satisfaction of the Competent Authority; or
- b. Extend the period of probation or discharge the probationer or terminate the services of the probationer, as the case may be, in accordance with the relevant rules and orders, if the probationer has not completed the period of probation satisfactorily.

The following documents in sealed envelope are placed below the Executive Council for consideration:

- Confidential Report of each Assistant Professor from concerned Dean and
- Confidential Report of each Dean & Associate Professor from Vice-Chancellor.

The powers of confirmation vests with the Executive Council, therefore, the matter regarding successful completion of probation period and confirmation of services of faculty of the University from the date of their joining is placed before the Executive Council for consideration.

#### The Executive Council considered and approved as under:

#### For the post of Professor:

i. \*Considered and approved the request of Prof. Asutosh Pradhan in larger interest of University with regard to not confirming his services in Mahatma Gandhi Central University along with the permission to maintain his lien for another period of one year i.e., upto 29<sup>th</sup> September 2018 in his parent department (i.e., Central University of Himachal Pradesh, Dharamshala).

## For the post of Associate Professor:

ii. Accepted the confidential report duly filled by the Competent Authority (Reviewing Authority) and as such approved the confirmation of all Associate Professors in the University from the date of their joining and ordered that Confirmation Order may be issued after completion of probation period only subject to the condition that no adverse report is being received by the University before the completion of their Probation Period.

#### For the post of Assistant Professor:

iii. Accepted the confidential report of all Assistant Professors (listed above at Sl. No. 12 to 64 at Table given at Para 1 on pre-pages) duly filled by the Competent Authority (Reviewing Authority) and as such approved the confirmation of all Assistant Professors except of (i) Dr Shashi Kant Ray, Assistant Professor, Department of Biotech and (ii) Dr Amit Ranjan, Assistant Professor, Department of Zoology, in the University from the date of their joining and ordered that Confirmation Order may be issued only after completion of probation period subject to the condition that no adverse report is received by the University before the completion of their Probation Period.

With respect to (i) Dr Shashi Kant Ray, Assistant Professor, Department of Biotech and (ii) Dr Amit Ranjan, Assistant Professor, Department of Zoology, the Executive Council (on the basis of confidential report) resolved that their services should be terminated in view of non-satisfactory performance during the probation period.

Item: EC (2017):07:05 To place before the Executive Council the matter regarding disposal of confidential documents related to recruitment.

The Mahatma Gandhi Central University is a new Central University and in nascent stage. At present, the University is running its academic and administrative functions from temporary buildings. There is an acute shortage of space because of which the University runs in two shifts. Due to lack of space in the temporary campus of the University, the University is not even in a position to provide adequate seating space to the faculty / Heads / Deans / Visitors. The library too has been adding books and titles to meet the increasing demands of new batches of students and new courses which are run in the new semesters.

Hence, the University finds it difficult to store used & unused hard copies of Question Booklets, OMR Sheets and other documents related to Recruitment. To manage its limited space, time and again the University has to shift its personnel and movable infrastructure from one building site to another. There are chances that during transportation these documents may get misplaced, therefore, the matter regarding disposal of

confidential documents related to recruitment is placed before the Executive Council for consideration and decision.

#### Item was withdrawn.

Item: EC (2017):07:06

To place before the Executive Council the matter regarding nomination of "Three Experts, known for their expertise / special interests in planning and development of Higher Education" in the Planning & Monitoring Board of the University.

The Ordinance No. 30 of the University deals with "Powers and Functions of the Planning and Monitoring Board". The Planning & Monitoring Board which shall advice the Academic and Executive Council on overall academic planning and development of the University including establishment and abolition of various Schools, Departments, Centres, Halls, Colleges and Institutions, if any, established or to be established by the University.

As per Clause 2(iii) of Ordinance No. 30 of the University, the Planning and Monitoring Board shall consist of:

"Three Experts, known for their expertise / special interests in planning and development of Higher Education, to be nominated by the Executive Council."

The matter is placed before the Executive Council for nomination of three experts, known for their expertise / special interests in Planning and Development of Higher Education.

The Executive Council authorised the Vice-Chancellor to nominate three experts in Planning & Monitoring Board on behalf of Executive Council.

Item: EC (2017):07:07

To place before the Executive Council the matter regarding nomination of members on the Selection Committees for the posts of Registrar / Finance Officer / Controller of Examinations.

The Selection Committees for the posts of Registrar, Finance Officer and Controller of Examination are likely to be held shortly. The Table Below Statute 18(2) of Central Universities Act 2009 dealing with the composition of the Selection Committee for these posts, provides for

- (i) Two members of the Executive Council nominated by it; and
- (ii) One person not in the service of the University nominated by the Executive Council.

The matter is placed before the Executive Council for nomination of members on the Selection Committees for the posts of Registrar / Finance Officer / Controller of Examinations.

The Executive Council authorised the Vice-Chancellor to nominate the members/experts in the Selection Committees on behalf of Executive Council.

To place before the Executive Council the Annual Accounts of the University for the Financial Year 2016-17.

The Annual Accounts of the University for the Financial Year 2016-17 **(ANNEXURE - 07.09)** have been prepared by OSD (Finance) of the University in terms of the provisions of Statute 7(7)(iii) of Central Universities Act 2009 who is responsible for the preparation of Annual Accounts of the University and for their presentation to the Executive Council. The Annual Accounts so prepared by the OSD (Finance) are required to be laid before the Finance Committee for consideration and comments in terms of Statute 17(7) and thereafter, the accounts are required to be submitted to the Executive Council for approval.

In this connection, it is pertinent to mention here that the said Annual Accounts of the University for the Financial Year 2016-17 have already been sent to Hon'ble Members of the Finance Committee of the University on 25th September 2017 for their consideration. The recommendation of Hon'ble Members of Finance Committee is yet to be received.

As per the instructions issued in this behalf by the Ministry of Human Resource Development, Govt. of India, issued vide their D.O. letter No.F.19-18/2003-IFD dated 23.5.2008, the Annual Accounts are required to be prepared and got adopted by the Executive Council by 30<sup>th</sup> June of the following year before being sent to the audit authorities for their suggestions/comments.

There has been delay in preparation of Annual Accounts of the University for the Financial Year 2016-17 due to inadequate and huge manpower crisis in Administration & Finance Department.

The Annual Accounts have been prepared strictly as per the Common Format of Accounts, guidelines and instructions issued by the University Grants Commission / Ministry of Human Resource Development consisting of Balance Sheet, Income & Expenditure Account, Schedules forming part of the Financial statements with significant accounting policies, contingent liabilities and Notes to the Accounts of the University. The Accounts have been prepared on accrual basis and taking into account the component of depreciation provided on Fixed Assets on Straight Line Method at the rates suggested by UGC applicable for Central Higher Educational Institutions.

Keeping in view the above, the matter is placed before the Executive Council for consideration and approval.

The Executive Council considered and approved the Item.
